

Privacy Statement – other situations

At AAMI there are times where in the ordinary course of our business we collect, hold, use and disclose personal information about individuals when they interact with us in a range of ways. These may be individuals who are not AAMI customers or they may be AAMI customers who are interacting with us in a capacity other than simply as a customer.

Why have we collected your personal information?

To enable:

- you to participate in the competition;
- us, and any other promoter or associated agency to run the competition, including administering, managing and promoting the competition, advising any relevant gaming authorities, and (should you be the winner) may publication of results or competition promotion in appropriate media; and
- us to get a better understanding of you, your needs, your behaviours and how you interact with us, so we can engage in product and service research, development and business strategy including managing the delivery of our services and products via the ways we communicate with you. (where specifically included in the terms and conditions of the competition) to provide you with marketing information .

What happens if you don't give us your personal information?

If we ask for your personal information and you don't give it to us you may not be able to enter the competition or be eligible to win any prizes.

We may collect and disclose your personal information to these persons and organisations during the information life cycle, regularly, or on an ad hoc basis, depending on the purpose of collection.

Where your personal information is collected or disclosed, it will be to achieve the purposes described in 'Why have we collected your personal information?' as well as purposes that are related, where you would reasonably expect us to. We also provide your personal information to other related companies in the Group, and they may disclose or use your personal information for those same purposes. They may also use your personal information to help them provide products and services to other customers, but they'll never disclose your personal information to another customer without your consent.

In this context, and depending on the nature of your complaint or query, we will generally collect your personal information directly from you, however, in some cases we may collect your personal information from, or disclose your personal information to:

- other companies within the Group and other trading divisions or departments within the same company – to see a list of our brands/companies, please see the Group Privacy Policy which can be accessed at www.aami.com.au/privacy
- any of our Group joint ventures where authorised or required;
- customer, product, business or strategic research and development organisation;
- data partners and analytic consultants;
- social media and other virtual communities and networks where people create, share or exchange information;
- publicly available sources of information;
- clubs, associations, member loyalty or rewards programs and other industry relevant organisations;
- a third party that we've contracted to provide financial services, financial products or administrative services – for example:
 - information technology providers,
 - administration or business management services, consultancy firms, auditors and business management consultants,
 - marketing agencies and other marketing service providers,
 - claims management service providers
 - print/mail/digital service providers, and
 - imaging and document management services;

- any intermediaries, including your agent, adviser, a broker, a representative or person acting on your behalf, other Australian Financial Services Licensee or our authorised representatives, advisers and our agents;
- a third party claimant or witnesses in a claim;
- accounting or finance professionals and advisers;
- government, statutory or regulatory bodies and enforcement bodies;
- policy or product holders or others who are authorised or noted on the policy as having a legal interest in a policy;
- in the case of a relationship with a corporate partner such as a bank or a credit union or another insurer, the corporate partner and any new incoming insurer;

Why have we collected your personal information?

To enable:

- us to identify you, confirm your eligibility and conduct appropriate checks;
- us to understand your requirements and provide you with access to the AAMI Skilled Drivers Course and online booking system;
- the set up, administration and management of your booking made with the AAMI Skilled Drivers Course;
- us to provide you with your results from participation in the AAMI Skilled Drivers Course and any related information as a result of your participation;
- us, where you provide us with any AAMI Comprehensive Insurance policy ("policy") details, to set up, administer and manage the AAMI Skilled Drivers Course and its interrelationship with that policy, including to assess the eligibility for and provide any applicable policy discount as a result of you completing the AAMI Skilled Drivers Course; and
- get a better understanding of you, your needs, your behaviours and how you interact with us, so we can engage in product and service research, development and business strategy including managing the delivery of our services and products via the ways we communicate with you.

What happens if you don't give us your personal information?

If we ask for your personal information and you don't give it to us you may not be able to participate in the AAMI Skilled Drivers Course and we may not be able to provide you with any, some, or all of the features of our products.

How we collect and disclose your personal information?

We also provide your personal information to other related companies in the Group, and they may disclose or use your personal information for those same purposes. They may also use your personal information to help them provide products and services to other customers, but they'll never disclose your personal information to another customer without your consent.



We collect your personal information directly from you. Where a parent, grandparent, guardian or some other person or organisation registers you for, or requests information or makes contact about the AAMI Skilled Drivers Course on your behalf, we also collect your personal information from them.

We may collect your personal information from, or disclose it to:

- a third party that we've contracted to provide administrative services – for example:
 - information technology providers and online booking system providers, such as iSmart Software;
 - print/mail/digital service providers, including SMS host providers;
 - administration or business management services, consultancy firms, auditors and business management consultants;
 - marketing agencies and other marketing service providers;
- imaging and document management services; customer, product, business or strategic research and development organisations;
- policy or product holders or others, including where you are an insured person or a listed driver, but not the policy or product holder;
- data warehouse, strategic learning organisations, data partners and analytic consultants;
- social media and other virtual communities and networks where people create, share or exchange information;
- publicly available sources of information;
- clubs, associations, member loyalty or rewards programs and other industry relevant organisations;
- any other organisation or person, where you've asked them to provide your personal information to us, or us to disclose your personal information to them, e.g. your parent or grandparent;
- other companies within the Suncorp Group and other trading divisions or departments within the same company (to see a list of our brands/companies, please see the Group Privacy Policy which can be accessed at www.aami.com.au/privacy);
- any of our joint ventures where authorised or required;
- the Financial Ombudsman Service or any other external dispute resolution body.

Your personal information and our marketing practices

We, and other people who provide us with services, may combine the personal information collected from you or others, with the information we, or companies in our Group, or our service providers already hold about you. We may also use online targeted marketing, data and audience matching and market segmentation to improve advertising relevance to you.
